GUIDELINES:

Inhouse concessions will be provided by Friends of the Passmore Center for consumption on the premises. Food items prepared by vendors should intended for off premises consumption to avoid competition with the Friends of Passmore Center. *All vendors are asked to assist with the promotion of this event including word of mouth and handing out flyers. *Your area should be attractive. *Vendors agree to stay until the close of the show. * Vendor fees will be forfeited under the following conditions: Vendor (1) is absent from the show, or (2) sells items that were not approved. Decisions regarding UNAPPROVED ITEMS will be made by the show director acting for the Friends of Passmore Center. The show director has final say in any disagreement. If the situation is not corrected the vendor will be asked to leave.

This show encourages items handmade by the vendors. Other items may be allowed at the discretion of the show director. No used or resale items permitted. *Vendors may keep 100% of sale.*Vendors are responsible for providing and securing his/her own labor, set-up, clean-up, product, equipment, and all other related materials and documentation necessary for operating the sale of their items (including compliance to federal/state sales tax regulations, etc.). **Nothing may be attached on the walls. *The Passmore Center will not take responsibility for vendor table or personal property.*Refunds will only be issued due to "inclement weather" or adverse environmental conditions resulting in the cancellation of the show. *Refunds will not be honored if vendor cancels after October 25, 2019.
