

I-693 APPOINTMENTS AT THE ORANGE COUNTY HEALTH DEPARTMENT

The Orange County Health Department (OCHD) is a designated Civil Surgeon for **refugee immunizations only**. Refugees who are seeking to adjust their status can make an appointment for an I-693 (which includes administration of additional required immunizations and completion of the vaccination portion of the I-693 form – Often the service needs to be split into two separate appointments).

Who qualifies for an I-693 appointment?

- People who have **lived in the US for close to a year**, are **getting ready to apply for permanent residency AND have REFUGEE STATUS**.

(Note: Children born in the US to refugees are citizens, and do not need to file immigration paperwork.)

What do I need to bring to the I-693 appointment?

- Government Issued Photo ID (example: your valid, unexpired passport or driver's license)
- For individuals under 14, USCIS accepts other proof of identity that shows name, date and place of birth, parents' full names and other identifying information. Acceptable documents include birth certificates (with translations if necessary) or affidavits.
- I-94 document
- Official Immunization/Vaccination Records (if you have any)
- Medicaid card (if you have one)
- Proof of income (e.g., last pay stub) for any family members working in the household.
- Money to cover any administrative costs or immunizations.

NOTE:

If OCHD is unable to provide an appointment during the client's requested time frame, refugees may inquire with other local health departments, who can also assist with I-693 appointments:

- *Wake County Human Services Clinic: 919-250-3900*

(Full Civil Surgeons may also provide the vaccination portion I-693 appointments.)

Asylees or people with an immigration status other than "refugee" need to be seen by a full Civil Surgeon. (Note: Refugees with a Class A status or individuals who were designated as a refugee after entering the US will also need to see a full Civil Surgeon).
